

Showmax-Capitec Campaign Terms and Conditions

1. These Showmax-Capitec campaign terms apply when you purchase a qualifying Showmax subscription plan ("Subscription Plan") on the Capitec app, where you may qualify for a 50% (fifty percent) discount on the retail price of the Subscription Plan ("Showmax-Capitec Campaign"). The Showmax-Capitec Campaign commences from 1 August 2024 to 31 July 2027, subject to these Showmax-Capitec Campaign terms and conditions.
2. By purchasing a Subscription Plan as part of the Showmax-Capitec Campaign, you represent and warrant that you agree to abide by, and to be bound by these Showmax-Capitec Campaign terms, as may be amended from time to time.
3. For purposes of this Showmax-Capitec Campaign, the following terms shall have the meaning assigned to them below:
 - 3.1. "Capitec" means Capitec Bank Limited;
 - 3.2. "Capitec App" means the digital application owned and operated by Capitec and used by customers to transact on their Capitec accounts;
 - 3.3. "Showmax" means Showmax SA Proprietary Limited;
 - 3.4. "Subscription Plan" means any of the following subscription products made available by Showmax from time to time as part of the Showmax service. For purposes of this Showmax-Capitec Campaign, these are - (i) General Entertainment Mobile; (ii) General Entertainment All Devices; and (iii) Premier League Mobile;
 - 3.5. "Showmax Service" means the service offered by Showmax which is the trade name and trademark proprietary to Showmax, which may be accessed by a digital interface, allowing the subscriber to access Live TV, Video-On-Demand film, series and kids content on selected devices; and
 - 3.6. "customer", "you" or "your" means a natural person who has an active Capitec Bank account and purchases a Subscription Plan via the Capitec App.
4. General information
 - 4.1. The Showmax-Capitec Campaign is only available and valid to customers in the Republic of South Africa, who have an active Capitec bank account and purchase a Subscription Plan on the Capitec App.
 - 4.2. Once the Subscription Plan is purchased, you will receive a Showmax voucher code on the Capitec App and/or via SMS sent to you or by any other means determined by Capitec.
 - 4.3. You will be granted an entitlement to view the specific Subscription Plan that you have purchased, for a period of 1 (one) month from the date of redemption ("Subscription Period").
 - 4.4. Should you wish to continue to subscribe for the Showmax Service applicable to the Showmax-Capitec Campaign prior to the expiry of your Subscription Period, or at any time thereafter, you will need to purchase another Subscription Plan on the Capitec App and you will get another 50% (fifty percent) discount on the retail price. You can add another Subscription Plan before your current Subscription Period expires.

- 4.5. You acknowledge that you will not be entitled to a refund, exchange or pro-rata payment should you cancel your Subscription Plan prior to the expiry of your Subscription Period.
5. Voucher redemption process
 - 5.1. If you are a new Showmax subscriber the following steps will apply to you after purchasing a Subscription Plan applicable to the Showmax-Capitec Campaign:
 - 5.1.1. visit the Showmax website at www.showmax.com
 - 5.1.2. click 'Redeem Voucher'
 - 5.1.3. enter the Showmax voucher code in the 'New to Showmax' section
 - 5.1.4. click 'Create Account And Redeem' and enter your details to create an account
 - 5.1.5. click create account and start watching.
 - 5.2. For existing Showmax subscribers the following steps will apply to you after purchasing a Subscription Plan applicable to the Showmax-Capitec Campaign:
 - 5.2.1. visit the Showmax website at www.showmax.com;
 - 5.2.2. click 'Redeem Voucher'
 - 5.2.3. enter the Showmax voucher code in the 'Already Have A Showmax Account?' section
 - 5.2.4. click 'Sign In To Redeem'
 - 5.2.5. enter your Showmax account details to sign in and start watching.
6. General
 - 6.1. Showmax and Capitec reserve the right to amend, suspend or cancel the Showmax-Capitec Campaign at any time by providing you with due prior notice.
 - 6.2. The Showmax Service is governed by the Showmax Terms and Conditions – South Africa and the Showmax Privacy Policy.
 - 6.3. In case of any inconsistency between these Showmax-Capitec Campaign terms and the Showmax Terms and Conditions – South Africa relating to the Showmax-Capitec Campaign, these Showmax-Capitec Campaign terms will prevail.
 - 6.4. Showmax will collect and process your personal information in compliance with the Protection of Personal Information Act 4 of 2013 in order to provide you with the Showmax Service and to fulfil our obligations to you.
