How to enter

1. Download the new Capitec Bank app if you haven't yet. To find it, simply search 'Capitec Bank' in your app store. Remember to first verify your email on your current app before you download it, that way you don't need to visit a branch.
2. If you don't have our banking app yet you will need to do the following:
 - Visit your nearest branch
 - Open an account
 - Verify your phone and email address
3. Follow the link to our [Snapchat lens](#), take a snap, save it and post on Twitter using the #NewCapitecApp and tag @CapitecBankSA. Only one valid entry per participant will be entered into the draw
