

Live Better Academy 'Credit Score Course' Competition Rules

Prizes

• 10 X R1 000 monthly cash prizes during 17 February 2023 – 28 February 2023

Competition period

The competition will run from 17 February 2023 and close on 28 February 2023.

How to enter

- Create an account on the Live Better Academy, or log in to your existing account
- Complete the **Building a Credit Score** course on the Live Better Academy with a knowledge level of 3 or above during the competition period ("valid entry") to be entered into a lucky draw to win one of the R1 000 prizes

Competition terms and conditions

- 1. The name of the campaign is "Live Better Academy 'Credit Score Course' Competition" and Capitec is the promoter
- 2. The competition will run from 17 February 2023 and close on 28 February 2023
- 3. The competition is open to natural persons
 - 3.1 Who are citizens, permanent residents or work permit holders, and living in, the Republic of South Africa ("RSA")
 - 3.2 Who are in possession of a valid RSA identity document or driver's licence or a valid passport endorsed with "permanent resident" status; or a valid work permit and;

- 6. The winners will be randomly selected by a computer-programmed algorithm
- 7. All valid entries collated will be entered into an automated random draw selection process within 7 (seven) business days after the last day of the month or as soon as reasonably possible after the last day of the month
- 8. Winners will be contacted telephonically or by email before the 15th of the following month and in the event that a winner cannot be reached by telephone or email after 3 (three) attempts within 4 (four) weeks from the time of the draw, the promoter reserves the right to draw another winner and the prize will be forfeited by such winner
- 9. Prizes are not transferable or negotiable
- 10. The cash prizes will be deposited directly into a Capitec savings account opened and maintained in the name of the winner within 2 (two) weeks of the winner being successfully contacted
- 11. Capitec Bank reserves the right to substitute any prize with another prize of similar commercial value
