# **Prizes**

- Great weekly prizes (vouchers)
- 10 x Home makeovers to be won

# Competition period

- The competition will run from 24 July 2023 3 September 2023 (11:59pm).
- Winners will be announced every week from Friday, 4 August (before 5pm).

#### How to enter

For automatic entry into the competition:

- Pay the smart way with Capitec a minimum of 5 times every week (there is no limitation to the number of entries you can earn weekly)
- Any 5 qualifying payments will count as one entry, i.e. the 5 payments do not need to be the same qualifying payment type
- · Payments cannot be carried over to the following week's draw. Each week requires its own minimum of 5 payments

# Qualifying payments

- Card payments in-store or online (debit/credit card)
