

# **Spur and Capitec Kids' Party Competition Rules**

#### **Prizes**

Stand to win 1 of 6 kids' birthday parties for yourself or to gift it to a loved one or charity of your choice.

Each birthday party will be:

- To the maximum value of R2 000
- For use at the nearest Spur restaurant

## Competition period

- 1. Competition period is 4 September 2023 30 November 2023 (23h59)
- 2. Winners will be contacted directly and announced each month the following dates before 5pm: 6 October 2023, 10 November 2023 and 8 December 2023

#### How to enter

For automatic entry into the competition, simply buy a Spur voucher on Capitec's digital channels (minimum value R150), during the Competition period.

## Competition terms and conditions

- 1. The campaign name is "Spur and Capitec Kids' Competition" and Capitec is the promoter ("The competition")
- 2. The competition will run from 4 September 2023 up to and including 30 November 2023 (11:59pm)
- 3. The competition is open to natural persons who are:
  - 3.1 Citizens and/or permanent residents of, and living in, the Republic of South Africa ("RSA")
  - 3.2 In possession of a valid RSA identity document, or a valid passport endorsed with "permanent resident" status
  - 3.3 18 (eighteen) years of age or older
  - 3.4 Not employees, whether permanent or contracted, of Capitec Bank or our Competition Partners
  - 3.5 Not family members of those directly involved in the competition execution or fulfilment, production, management or marketing of the competition
  - 3.6 Meet the entry criteria applicable to this competition
- 4. Capitec, its affiliates, employees, advertising agencies and suppliers will not be liable for the failure of any technical element relating to the competition that may result in any entry not being successfully submitted
- 5. The winners will be randomly selected by a computer-programmed algorithm at specific dates during the competition period for purposes of drawing the Competition prize. All valid competition entries will be entered into an automated random draw selection process monthly, for the period 2 October 2023 to 8 December, 5pm. Winner draws will take place on 2 October, 3 November and 4 December
- 6. Monthly winners will be contacted directly by an individual in the employ of Spur, to allocate the Competition prize
- 7. Prizes: Each Capitec client who is successfully entered into the competition stands a chance to win only 1 (one) of 6 (six) of the following Prizes:
  - 7.1 Month 1 October:
    - 1 (one) x sponsored birthday party valued at R2 000 to use at the Spur restaurant nearest to the winner
  - 7.2 Month 2 November:
    - 2 (two) x sponsored birthday parties valued at R2 000 each to use at the Spur restaurant nearest to the winners
  - 7.3 Month 3 December:
    - 3 (three) x sponsored birthday parties valued at R2 000 each to use at the Spur restaurant nearest to the winners
  - 7.4 The Competition prize will include:
    - a) A birthday combo meal valued at R99.90 per child. The meal includes:
    - A selected kid's meal
    - A fruit juice/soda
    - A soft serve ice cream
    - A party box
    - b) The maximum value applicable to each Competition prize is R2 000
- 8. The type of Competition prize, and the value thereof, awarded to the successful Competition participant will be determined by Capitec, acting in its sole discretion. The Competition prize is exclusively for the benefit of the successful Competition participant. Competition prizes and are not transferable, not exchangeable and cannot be exchanged for their cash value

- 10. For the monthly prizes, the following terms and conditions will apply:
  - a) The Competition prize is valid for only 12 (twelve) months as from the date of issue
  - b) The Competition prize can only be redeemed at participating Spur restaurants
  - c) The Competition prize can only be redeemed instore
  - d) The Competition prize is not for resale and cannot be exchanged for cash
  - e) There will be no refund or exchanges allowed on any products or services purchased with the Competition prize
  - f) No change will be given in the event that the Competition prize is not used within the specified period, or should there be a balance remaining after redemption of a portion of the Competition prize, same will be for
- 11. Your entry and/or participation in the Competition and/or your acceptance of the Competition prize (in the event that you win a prize) constitutes your binding acceptance of the Competition rules
- 12. Should any dispute arise in relation to the interpretation of these Competition rules, Capitec's decision shall be final, and no correspondence shall be entered into
- 13. You may not win a Competition prize if it is unlawful for us to supply such a prize to you. You must be eligible to win the Competition prize

Any documents, permissions and/or any legal or regulatory requirements that may be required by these rules or any other applicable law in order to accept and use a Competition prize, shall remain your responsibility to obtain and/or observe at your own cost, and which documents and permissions must remain valid in such minimum form required by these Competition rules or any other applicable law

Capitec, its affiliates, employees, advertising agencies and suppliers will not be responsible, and hereby disclaim all liability, for any loss, injury or death, expense or damage (whether direct, indirect, incidental, punitive or consequential) of any nature, whether arising from negligence or any other cause, which is suffered by your participation in the Competition or the acceptance and/or use by you, of any prize, or by any action taken by the promoter or any of its affiliates, employees, advertising agencies and suppliers in accordance with the competition rules
- 16. Competition participants understand and agree that in order to offer the competition, Capitec may collect and use personal information about the participants. This competition is conducted under the terms of the applicable privacy laws. Personal information collected will:

  - b) Not be shared with any third parties without obtaining consent from the winners
  - c) Be processed in accordance with Capitec Privacy Policies

- 18. Subject to the participants' right to expressly accept, decline and withdraw consent or participation, Capitec may:

If Capitec is required by the Minister of Trade and Industry to alter any aspect of the competition or to terminate the competition as a result of changes in legislation, the promoter will have the right to terminate the competition with immediate effect and without notice of such termination. In such event, all participants hereby waive any right which they may have against Capitec, its affiliates, employees, advertising agencies and suppliers
