Prize

How to enter

Weekly Points Target Prize

- Earn points by completing learning and **correctly answering questions** in any of the Courses, Recap room or Quiz room on the MoneyUp Academy. The points allocated per activity are specified on your dashboard.
- Reach your Weekly Points Target at any time between 00h00 (midnight) Monday and 23h59 Sunday of a calendar week to be immediately entered into an instant randomized draw and to stand a chance to win a Capitec Flexi Voucher up to the value of R 200 (two hundred rands)
- The Weekly Points Target is 4 000 points. Reaching this target qualifies one active account for one entry only during any calendar week.
- Your Weekly Points will reset to zero at 00h00 (midnight) every Monday, giving you a new chance to hit the Weekly Target in the following week.
- You can enter every week and, if you reach your Weekly Points Target, you are eligible to win a Capitec Flexi Voucher.
