

Simple Moments Made Better VAS Competition Rules

Competition Prize

How to enter

- 1. The campaign name is "Simple moments made better VAS Competition" and Capitec Bank Limited ('Capitec') is the promoter ('the Competition')
- 2. The competition will run from 25 March 2024 up to and including 31 May 2024 (11:59pm)
- 3. The competition is open to natural persons who:
 - 3.1 Are citizens and/or permanent residents of, and living in, the Republic of South Africa ("RSA")
 - 3.2 Are in possession of a valid RSA identity document, or a valid passport endorsed with "permanent resident" status
