Competition period

Competition period is 15 April 2026 – 27 April 2026 until 23h59.

How to enter

VIP Tickets: Create your own limited-edition cover design for our comic book, tag us on the competition post and you could win.

Winner selection

Participants will be eligible for one randomised draw one (1) day after each competition post is published and the winners will be contacted within two (2) days from the date the Competition ends.

Competition terms and conditions

1. The promoter is Capitec Bank Limited with registration number 1980/003695/06 (“Capitec” or “We”).
2. The name of the Competition is “Capitec x Comic Con Cape Town – Ticket Competition” (“the Competition”).
3. The Competition is open to natural persons, who meet the following criteria:
 - 3.1 cannot be a Capitec employee or contractor.
 - 3.2 must be an RSA resident and be able to provide their own transportation to and from the event venue.
 - 3.3 must be above 18 years of age.
