

# Workplace Banking Klerksdorp Hospital Campaign Competition Rules

## Prize

## How to enter

Visit the Workplace Banking team and switch your salary to Capitec between 1 November 2018 and 28 February 2019.

  - 4.1. who are citizens of, and living in, the Republic of South Africa, and
  - 4.2. who switch their salary to Capitec, and who are employees of the companies/hospitals where Capitec's Workplace Banking teams have promoted this competition
5. Your name will be entered into the competition if you comply to the above (4.2). This will be considered a valid entry into the competition prize draw
