

Sun Met Twitter Competition Rules

Prize

1 x VVIP hospitality tickets to the Sun Met 2019 for the winner and 5 friends.

Competition rules

1. The name of the competition is "Sun Met Twitter Competition" and Capitec Bank is the promoter of the competition
2. The competition runs from 2 – 11 January 2019 ("competition period")
3. The competition closes on Friday, 11 January 2019 at 2pm
4. The competition is open to natural persons
 - 4.1. who are citizens of, and living in, the Republic of South Africa, and
 - 4.2. who hold an active Capitec Bank account (Global One debit card or credit card) on 2 January 2019 and before date of entry into the competition
 - 4.3. who is 18 years and older
 - 4.4 who have their own transport and accommodation to attend the Sun Met event on 26 January 2019 at Kenilworth Racecourse, Cape Town
 - 4.5 who are not excluded in terms of the competition rules, including but not limited to rule 17 below
5. In order to be eligible for entry into the competition, you need to comply with the above conditions
6. This is a social media competition that will be run on Twitter. To enter, retweet our original competition post during the competition period. All valid entries will be collated on 15 January 2019 for entry into a random draw for the VVIP hospitality tickets to the Sun Met 2019. There will only be 1 (one) winner who will be randomly selected by a computer programmed algorithm. Only 1 retweet, and therefore only 1 entry, is allowed per person
7. The winner will be contacted through their social media handle
 - 7.1 The winner is required to respond within 24 hours of the social media contact. After 3 failed attempts to contact the winner, they will forfeit the prize and the second-drawn winner will be contacted
 - 7.2 The winner will be contacted to verify their contact details, identity (including identity number), that they have a Capitec Bank account in their name and any other relevant information to ensure their eligibility. If the winner is not eligible in any way, they will forfeit the prize and the second-drawn winner will be contacted
 - 7.3 If the winner does not have a Capitec Bank account at this time, they will forfeit the prize and the second-drawn winner will be contacted
 - 7.4 Prize includes VVIP hospitality tickets for the winner and 5 (five) friends only
 - 7.5 Prize does not include any transport or accommodation costs
 - 7.6 Prize is not negotiable and cannot be transferred or exchanged for cash
