

Marktfees Facebook Competition Rules

Prize

Win one of 8 R500 vouchers to spend at this year's Marktfees from 31 October to 3 November 2018 at the Tramways Building in Port Elizabeth.

How to enter

Simply like and share our original competition post during the competition period for entry into a random draw to win one of 8 R500 vouchers to spend at this year's Marktfees.

2. The competition runs from 19 October – 28 October 2018 ("competition period")

 - 4.1. who are citizens of, and living in, the Republic of South Africa, and
 - 4.2. who hold an active Capitec Bank account (Global One debit card or credit card) on 19 October 2018 and before date of entry into the competition
 - 4.3. who is 18 years and older
 - 4.4 who have their own transport and accommodation to attend the Marktfees event on 31 October until the 3rd of November at the Tramways Building
 - 4.5 who are not excluded in terms of the competition rules, including but not limited to rule 17 below

6. This is a social media competition that will be run on Facebook. To enter, like and share our original competition post during the competition period. All valid entries will be collated on 29 October 2018 for entry into a random draw to win one of 8 R500 Vouchers. There will only be 8 (eight) winners who will be randomly selected by a computer-programmed algorithm
7. The winners will be contacted through their social media handle
 - 7.1 The winners are required to respond within 24 hours of the social media contact, or else they forfeit the prize
 - 7.2 The winners will be contacted to verify their contact details, identity (including identity number), that they have a Capitec Bank account in their name and any other relevant information to ensure their eligibility
 - 7.3 If the winner does not have a Capitec Bank account at this time, they will forfeit the prize and the second-drawn winner will be contacted
 - 7.4 Prize does not include any transport or accommodation costs
8. We may request that the winners shares the experience on their own social media pages. The winners will be given the opportunity to decline this option
