How to enter

Download and use the Capitec Masterpass™ app to purchase Cascades Wine and Food Festival 2018 tickets at the Cascades Lifestyle Centre's ticket sales desk between 20 September – 25 October 2018 to qualify.

 - 4.2. who purchase their Cascades Wine and Food Festival Tickets using the Capitec Masterpass app.

6. All valid entries will be collated on 26 of October 2018 for entry into a random draw for the R5 000 Capitec voucher
