

Capitec London Roots Switch Promotion rules

Promotion

You could qualify for 2 x general access tickets to the Capitec London Roots event taking place on 26 December 2019 at Buffalo City Stadium, East London.

How to qualify

- Switch your salary or debit orders to Capitec at one of the 17 participating East London and surrounding branches and receive 2 x general access tickets to the Capitec London Roots event
- The first 600 qualifying clients will receive tickets. Tickets are issued on a first come, first served basis until they are finished
- Note that there are a total of 600 tickets available to all 17 participating branches, meaning only 34 tickets are issued per branch

Participation rules

2. The promotion runs from 15 November – 15 December 2019
3. The promotion ends on Sunday, 15 December 2019 at 1pm
4. The promotion is open to natural persons:
 - 4.1 who are citizens of, and living in, the Republic of South Africa and;
 - 4.2 who either switch their salary or their debit orders to Capitec during the promotional period at any of the participating East London and surrounding branches;
 - 4.3 who are 18 years and older
5. You will receive 2 x general access tickets to the Capitec London Roots event if you do any one of the above (4.2), and are one of the 600 qualifying clients
6. The tickets include general access to the Capitec London Roots event. Clients must provide their own transport and accommodation, it does not form part of the general access ticket or the promotion
7. The tickets are not transferable, negotiable, nor can they be exchanged for cash; they are procured directly from the event organisers
