

Capitec London Roots Twitter Competition rules

Prize

How to enter

Simply retweet the original @CapitecBankSA competition post with #CapitecLondonRoots during the competition period for entry into a random draw. Only one valid entry will be entered into the draw.

Competition rules

1. The name of the competition is "Capitec London Roots Twitter competition" and Capitec Bank is the promoter of the competition
2. The competition runs from 2 – 13 December 2019 ("Competition Period")
3. The competition closes on Friday, 13 December 2019 at 11:55pm
4. The competition is open to natural persons:
 - 4.1 who are citizens of, and living in, the Republic of South Africa; and
 - 4.2 who hold an active Capitec account (Global One debit card or credit card) on 2 December 2019 and/or before the date of entry into the competition;
 - 4.3 who are 18 years and older;
 - 4.4 who have their own transport and accommodation and are able to attend the Capitec London Roots event on 26 December 2019 at Buffalo City Stadium, East London;
 - 4.5 who are not excluded in terms of the competition rules, including but not limited to rule 17 below
5. To be eligible for entry into the competition, you need to comply with the above conditions
6. This is a social media competition that will be run on Twitter. To enter, retweet our original competition post with #CapitecLondonRoots during the Competition Period. All valid entries will be collated on 14 December 2019 for entry into a random draw for the 6 x VIP tickets to the Capitec London Roots event. There will only be one winner, randomly selected by a computer-programmed algorithm
7. The winner will be contacted on Twitter, using the Twitter handle they entered the competition with
 - 7.1 The winner is required to respond within 24 hours of being contacted on Twitter, or else they forfeit the prize;
 - 7.2 The winner will be contacted to verify their contact details, identity (including identity number), that they have a Capitec account in their name and any other relevant information to ensure eligibility of selected winner;
 - 7.3 If the winner does not at this time have a Capitec account, they will forfeit the prize and the second drawn winner will be contacted;
 - 7.4 The prize does not include transport or accommodation costs
