

Go Cashless Competition Rules

Prizes:

Transact on your Capitec card and stand a chance to win 1 (one) of 10 (ten) cash prizes worth R10 000 each during 16 July 2019 – 14 November 2019 ("Competition Period").

How to enter:

To qualify, you have to make a purchase with your Capitec card during the competition period. For every transaction on your Capitec card you automatically qualify for one entry into a lucky draw.

Campaign and competition rules:

1. The name of the campaign is "Go Cashless" and Capitec Bank is the promoter of the Competition
2. The competition for a share of R100 000 in cash prizes runs from 16 July 2019 and closes at 11:59pm on 14 November 2019 ("Competition Period")
3. You stand a chance to win R10 000 cash paid into your Capitec account if you transact on your Capitec card during the competition period. For each card transaction you qualify for one entry

 - 4.1. Who are citizens of, and living in, the Republic of South Africa, and this campaign is only open to persons over the age of 18 years
 - 4.2. Who is a Capitec client, with all Capitec accounts being in good standing
