

Capitec Masterpass™ Campaign

Instant Prize:

A Woolworths gift card valued at R100. Gift cards are limited to a maximum of 10 per participant for the duration of the competition period

How to qualify:

Capitec clients must use the Capitec Masterpass app to make 3 Capitec debit or credit card QR code purchases between 1 October 2019 and 12 November 2019, in order to get a R100 Woolworths gift card. Clients who qualify for a gift card will also get an automatic entry into a lucky draw to stand a chance to win 1 of 9 Huawei P30 Pros every week of the competition. The minimum spend per Capitec Masterpass app transaction is R30. **QR code payments may be done using Zapper, Snapscan or Masterpass QR codes only.**
