

Capitec Move Your Money Gameshow Competition Rules

Prize

- Gameshow contestants will stand a chance to win cash prizes of up to R20 000 per show
- A viewers' competition will run where contestants can win a share of R50 000 in cash prizes

Competition period

The Competition will run from 20 January 2020 ("Commencement Date") and close on 4 March 2020 ("Closing Date").

How to enter

To be a contestant on the Move Your Money Gameshow on TV, a participant must follow the steps below:

- Dial *120*218*8#
- Follow the prompts and respond to the questions

After the Closing Date, Capitec's promotional agency, Red Cherry Media Holdings (Pty) Ltd ("Agency") will choose the contestants by a random draw from the database received from the USSD (*120*218*8#) dial string collection.

To enter the Viewers' Competition and win a share of R50 000 in cash prizes:

- SMS the answer to the weekly question to 33593
- SMSs cost R1 each

How the gameshow works

Each team of contestants will get to answer 2 questions worth R2 500 (two thousand five hundred rand) per correct answer. There will be a final bonus question and the team that taps their card first will get to answer the bonus question. If answered correctly, they will walk away with a total of R10 000 (ten thousand rand).

For the Viewers' Competition, 2 winners will be drawn each week. All participants that answered the question correctly will be entered into an automated random draw. Winners will be contacted telephonically.

Competition terms and conditions

1. The name of the campaign is "Capitec Move Your Money Gameshow" and Capitec Bank Limited is the Promoter of the competition
2. The Competition is open to natural persons –
 - 2.1 Who are citizens and/or permanent residents of, and living in, the Republic of South Africa ("RSA")
 - 2.2 Who are in possession of a valid RSA identity document or driver's licence or a valid passport endorsed with "permanent resident" status; and
 - 2.3 Who are eighteen (18) years of age or older ("Participants")
3. 7. Cash prizes will be deposited directly into a Capitec Bank savings account opened and maintained in the name of the winner
8. Contestants will be contacted telephonically during the competition period
9. If we are unable to reach a selected contestant or winner telephonically after three (3) attempts were made during the course of that week, we reserve the right to select another contestant or winner
10. Selected contestants will need to be available to fly to Johannesburg to take part in the gameshow. Should they reside outside of Johannesburg, the Promoter's agent will handle all the travel arrangements and costs
11. The Promoter reserves the right to substitute any prize with another prize of similar commercial value
12. The Promoter reserves the right to vary, postpone, suspend or cancel the competition and any prizes, or any aspect thereof, without notice at any time, for any reason which the promoter deems necessary. In the event of such variation, postponement, suspension or cancellation, you agree to waive any rights, interests and expectations that you may have in terms of this Competition and acknowledge that you will have no recourse against the Promoter, its affiliates or suppliers
13. Your entry and/or participation in the Competition and/or your acceptance of the prize (in the event that you win a prize) constitutes your binding acceptance of the Competition rules
14. Should any dispute arise in relation to the interpretation of these Competition rules, the Promoter's decision shall be final and no correspondence shall be entered into
15. You may not win a prize if it is unlawful for us to supply such a prize to you. You must be eligible to win the prize
16. Any documents, permissions and/or any legal or regulatory requirements that may be required by these rules or any other applicable law in order to accept and use a prize, shall remain your responsibility to obtain and/or observe at your own cost, and which documents and permissions must remain valid in such minimum form required by these rules or any other applicable law

The Promoter, its affiliates, employees, advertising agencies and suppliers will not be responsible, and hereby disclaim all liability, for any loss, injury or death, expense or damage (whether direct, indirect, incidental, punitive or consequential) of any nature, whether arising from negligence or any other cause, which is suffered by your participation in the Competition or the acceptance and/or use by you, of any prize, or by any action taken by the promoter or any of its affiliates, employees, advertising agencies and suppliers in accordance with the Competition rules
18. If you fail to comply with any of the Competition rules, then without prejudice to any other remedy which we may have, you will be automatically disqualified and you will forfeit the prize(s) (in the event that you have already won a prize)

By participating in the Competition, each participant consents to the processing of his or her personal information and to the use of such personal information for the purpose of future communications from Capitec to the participant; provided that the participant shall be entitled at any time to opt out of such communications

21. The contestants will be required to take part in a video recording to be conducted by the Promoter through its agent. By participating, contestants consent to video recordings of their image for use by the Promoter on its promotional material and/or any other form of media. The contestants will not be entitled to any payment or other remuneration for any such recording or otherwise
22. All and any materials, including publicity materials, will be the sole property of the Promoter
23. If the Promoter is required by the Minister of Trade and Industry to alter any aspect of the Competition or to terminate the Competition as a result of changes in legislation, the Promoter will have the right to terminate the Competition with immediate effect and without notice of such termination. In such event, all participants hereby waive any right which they may have against the Promoter, its affiliates, employees, advertising agencies and suppliers
24. Income taxes relating to the prizes, if any, are the sole responsibility of the prize winners
25. These Competition rules will be construed, interpreted and enforced in accordance with the laws of the Republic of South Africa
