

# Live Better Academy Competition Rules

## Prizes

## How to enter

Winners will be contacted telephonically or by email before the 15th of the following month and in the event that a winner cannot be reached by telephone after 3 (three) attempts within 4 (four) weeks from the time of the draw, the promoter reserves the right to draw another winner and the prize will be forfeited by such winner

10. The cash prizes will be deposited directly into a Capitec Bank savings account opened and maintained in the name of the winner within 2 (two) weeks of the winner being successfully contacted
