

Livin' It Up Twitter Competition Rules

Prize

3 x R5 000 cash prizes.

How to enter

1. Download the Capitec Livin' It Up mobile game from your app store (existing players to update to the latest version of the game)
2. Unlock Nandi or Sanjay
3. Use the camera (next to the suitcase icon) to take a screenshot of Nandi or Sanjay's homes (any room in Sanjay or Nandi's homes will count as a valid entry), and share it on Twitter with the official hashtag #BeatTheLevels and tag @CapitecBank
