

Livin' It Up Competition 2 Rules

Prize

2 x R10 000 monthly cash prizes (January – February 2020) only payable into a Capitec account held by the lucky draw winner.

How to enter

All Livin' It Up mobile game users who've entered their cellphone number and given consent to have their Livin' it Up profile linked to their Capitec profile, will be entered into a lucky draw to win one of the prizes.

Competition terms and conditions

1. The name of the competition is "Livin' It Up Competition 2"
2. The competition will run from 1 January 2020 – 29 February 2020
3. To be eligible to win the monthly prize, you must meet the following criteria at the end of the calendar month:
 - 3.1 You must have played the Livin' It Up game in the calendar month
