

Live Better Academy Competition Rules

Prizes

2 x R5 000 monthly cash prizes during January – December 2021.

Competition period

The competition will run from 1 January 2021 and close on 31 December 2021.

How to enter

- Complete all 4 courses in the Be Money Smart series and achieve a series knowledge level of 5 or more (“valid entry”) during the competition period to be entered into a lucky draw to win one of the R5 000 cash prizes for the month
- You do not have to complete all 4 courses and reach the required knowledge level in the same month. You will automatically be entered into the lucky draw in the month in which you achieve a series knowledge level of 5 or more

2. The competition will run from 1 January 2021 and close on 31 December 2021

 - 3.1 Who are citizens and/or permanent residence of, and living in, the Republic of South Africa (“RSA”)
 - 3.2 Who are in possession of a valid RSA identity document or driver’s licence or a valid passport endorsed with “permanent resident” status; and

4. 6. The winners will be randomly selected by a computer-programmed algorithm
7. All valid entries collated will be entered into an automated random draw selection process within 7 (seven) business days after the last day of the month or as soon as reasonably possible after the last day of the month
8. Winners will be contacted telephonically or by email before the 15th of the following month and in the event that a winner cannot be reached by telephone or email after 3 (three) attempts within 4 (four) weeks from the time of the draw, the promoter reserves the right to draw another winner and the prize will be forfeited by such winner
9. Prizes are not transferable or negotiable
10. The cash prizes will be deposited directly into a Capitec savings account opened and maintained in the name of the winner within 2 (two) weeks of the winner being successfully contacted
