

Live Better Academy Competition Rules

Prizes

- 3 X R5 000 monthly cash prizes during March 2022 – August 2022
- 2 x R10 000 monthly cash prizes during March 2022 – August 2022

Competition period

The competition will run from 1 March 2022 and close on 31 August 2022.

How to enter

- Create an account on the Live Better Academy, or log in to your existing account
- Complete any one Live Better Academy course with a knowledge level of 3 or above during a month in the competition period ("valid entry") to be entered into a lucky draw to win one of the R5 000 prizes for that month
- Complete any 3 courses during a particular month in the competition period and achieve an overall knowledge level of 3 ("valid entry") to be entered into a lucky draw to win one of the R10 000 cash prize for that month
- You do not have to complete the course(s) and reach the required knowledge level in the same month. You will automatically be entered into the lucky draw in the month in which you achieve the required knowledge level

2. The competition will run from 1 March 2022 and close on 31 August 2022
3. The competition is open to natural persons –
 - 3.1 Who are citizens, permanent residents or work permit holders, and living in, the Republic of South Africa ("RSA")
 - 3.2 Who are in possession of a valid RSA identity document or driver's licence or a valid passport endorsed with "permanent resident" status; or a valid work permit and;
 - 3.3 Who are 18 (eighteen) years of age or older

Winners will be contacted telephonically or by email before the 15th of the following month and in the event that a winner cannot be reached by telephone or email after 3 (three) attempts within 4 (four) weeks from the time of the draw, the promoter reserves the right to draw another winner and the prize will be forfeited by such winner
9. Prizes are not transferable or negotiable
10. The cash prizes will be deposited directly into a Capitec savings account opened and maintained in the name of the winner within 2 (two) weeks of the winner being successfully contacted
