

Sending You Cash Social Media Competition Rules

Prize

R3 000 per social channel, per week.

How to enter

Facebook: Tag a social user.

Twitter: Retweet and tag a social user.

Competition rules

Please read these Terms and Conditions carefully. The Terms and Conditions set out below apply to all participants entering the 'Sending you cash' social media competition, conducted by Capitec Bank (the promoter).
