

Go Cashless: Competition Rules

Prizes

Transact on your Capitec card and be entered into a lucky draw to stand a chance to win 1 (one) of 10 (ten) cash prizes worth R10 000 each.

Competition period

The monthly lucky draws will take place:

- Between 16 July 2019 – 16 September 2019 ("Competition Period")
- July : 3 winners
- August : 3 winners
- September : 3 winners

How to enter

To qualify for the monthly draw, you have to make a purchase with your Capitec card during the competition period. For every transaction on your Capitec card you automatically qualify for one entry.

Campaign and competition rules

1. The name of the campaign is "Go Cashless" and Capitec Bank is the promoter of the Competition
2. The competition for a share of R90 000 in monthly cash prizes runs from 16 July 2019 and closes at 11:59pm on 16 September 2019 ("Competition Period")
3. You stand a chance to win R10 000 cash paid into your Capitec account if you transact on your Capitec card during the competition period. For each card transaction you qualify for one entry

 - 4.1 Who are citizens of, and living in, the Republic of South Africa, and this campaign is only open to persons over the age of 18 years
 - 4.2 Who is a Capitec client, with all Capitec accounts being in good standing
5. Your contact details will automatically be entered into the lucky draw when you perform a card transaction. This will be considered a valid entry into the lucky draw. Winners are not eligible for entry into the second or third draw (3.)
6. All valid entries will be collated on a monthly basis for the duration of the competition period for entry into a random draw to stand a chance to win a cashback prize based on transactions done on a Capitec card during the period of the competition

9. Cash prizes will be deposited directly into the winner's Capitec account
