How to enter

You must open a Capitec Bank transaction/savings account during the competition period from 1 November 2017 to 31 January 2018.

 - 4.3. who have opened a Capitec Bank transaction/savings account

Your name will be entered into the competition if you have opened a Capitec Bank account at any stage during the competition, which will be considered a valid entry into the monthly competition and prize draw.
